Security according to law and pay him his costs by him in this behalf expended. And the said Rockelle refusing to give the said security or a release from his debts and promises given and affirmed to recollect and remit. And thereupon the Court doth adjudge the said Henry Rockelle, guardian of the land Martha Rockelle and the said Henry Rockelle with Robert Pugh his security entered into and acknowledged a bond in the penalty of four hundred dollars and more according to law.

Bennett P Brigg is appointed Surveyor of the road from the beginning at the Towne ~~cross~~^{crossing} road to the Surveyor in the name of William Brigg dec^d. Said it is ordered that the said lands do work theron.

The Court being of opinion that the lands in this County ought to be partitioned with the following order and direct that the County be divided into 39 parcels as follows-

Precinct No. 1. From Holloway river up the great branch to Cradford road, down said road to Holloway river and down the said river to the beginning-

No. 2. From the north side of the flat swamp from the old parish line down the Robin branch and up that to the Angelus swamp, up the same to Robins branch and up that to the flat swamp and down the flat swamp.

No. 3. Boundeth by the Michaux River and the flat swamp and from the old parish line to the flat swamp and south to Thomas banks.

No. 4. Between Holloway River, Long bridge road, the three creeks and Cradford road-

No. 5. All the lands lying east of the Bartram swamp, Holloway River, the Indian river and the main road sometimes called the Creek road.

No. 6. From the Angelus swamp bridge, up the branch to Townes branch, up the said branch to the Angelus swamp, then down Barrows road to the head of Buckhorn, down that to the main road and by the said road to the beginning.

No. 7. From the mouth of Ridgelys branch to the head of Georges branch, down that to the Rose meadow, up that to Robins branch, up that to the head of the Angelus swamp and down the said branch to the beginning.

No. 8. From Robins branch up the south side of the three creeks to the County line to the Michaux river, down the said river to Thomas banks lands and thence to Robins branch.

No. 9. From the former parish line down the flat swamp to Cradford road and along the said road to the County line and up the said line to the Greenville line, up that to the old parish line and along the said line to the beginning.

No. 10. From Cradford road down the flat swamp to the County line to Cradford road along the said road to the beginning.

No. 11. From the mouth of Blants swamp to the mouth of Rose swamp up that to the Indian line down the said line to Cradford road, up the said road to the said swamp and up the same to the beginning.

No. 12. From the parish line at the flat swamp down the said swamp to the mouth of Blants swamp up the same to the mouth of Rose swamp, up that to the Indian line along the said branch to Townes branch, down that to the Angelus swamp and up that to the head of the Latur branch, down the said branch to the old parish line to the beginning.
