

- No. 13. From the old county line to the south side of the Bigfoot swamp and up the said road along the said Road to the County line, down the said line to the County line, thence the beginning of  
 No. 14. From the County line, rd. Brown road, up the said road to the mouth of flat swamp adjacent to Joseph Evans's, thence along Taylor road to Hutchinson's, thence down the said field to the Bigfoot swamp, down the said swamp & Brown road, up the said to the beginning -
- No. 15. From Simon Carville along Taylor road to Hutchinson's swamp up the swamp to the swamp to Brown road, up said road to the flat swamp and down the said swamp to the beginning -
- No. 16. From the mouth of the great swamp, up the said swamp to the head, thence along the line of the Rev. Mr. Harley to the head of Dicks swamp, then down the said swamp to the river, up the said river to the mouth of Dick's watershed swamp, up the said swamp to the beginning -
- No. 17. From the mouth of Dicks branch to the head of George branch, down the said branch & Ross's, up that to Reavis branch, down the said branch to the three creeks, down the three creeks to the mouth of the Angelina swamp, up the same to the beginning -
- No. 18. From the mouth of the three creeks, up the same to the mouth of the Starn swamp, up the same to the County line, down that to Attorney River and down the River to the beginning -
- No. 19. From the mouth of Starn swamp, up the same to the County line up said line to the poplar swamp, down the said swamp to the three creeks and down the creeks to the beginning -
- No. 20. From the mouth of the poplar swamp, up the same to the County line, up the said line to the three creeks and down the three creeks to the beginning -
- No. 21. From the buckhorn bridge up the swamp to the old Indian line, along the said line to Banks' house road, up the said road to the beginning -
- No. 22. From Mudall's on the goat road at the flat swamp, down the said swamp to the mouth of Cox's swamp up the said swamp to the road, up said to the beginning -
- No. 23. From the attorney river North Carolina line to the old plantation line -
- No. 24. Bounded by the old plantation line, Black water and plantation River -
- No. 25. From the lands lying on the east side of St. Brown's road lying on the old plantation line, thence up the Black water to David Johnson's, up the former side to the aforesaid road -
- No. 26. From all the lands of David Johnson on Black water road, up the Bigfoot swamp to the road and down the road to the former line -
- No. 27. From all the lands on the West side of St. Brown's road and up Attorney swamp to the old parish line, along the said line to the Bigfoot swamp and down the same to the road -
- No. 28. Between Attorney swamp, Attorney River and the old parish line -
- No. 29. All the lands between Black water and the Bigfoot swamp -
- No. 30. All the lands from the former parish line, between Black water and Seabrook to Frank's bridge down Black creek to Black water -
- No. 31. From the old parish line to Broad water road and down the said road to Round Hill swamp down the same to the beginning -
- No. 32. From the broad road up Seabrook to the County line and thence to Black water, and down Black water to the said road -
- No. 33. Between Round Hill, the lightwood and the County line -
- No. 34. Between round hill, Black creek the Apopomink and the County line -
- No. 35. Between the Apopomink attorney river and the County line -
- No. 36. From the former Parish line, thence to the head of Black creek and the Apopomink and down the swamp to Attorney River down back over to the former parish line -
- No. 37. Between, Seabrook, Black water and Broad water roads -
- No. 38. Beginning at the mouth of Dicks swamp, up that to the main road, along same
