

13. From the old County line to the Smith side of the Poplar Swamp and up the same to Ross road, along the said Road to the County line, down the said line to the County line, thence the beginning.
14. From the County line at Ross road, up the said road to the mouth of flat swamp, up that to Joseph Coville, thence along Taylor road to Whiteoak Grove, thence down the said path to the Poplar Swamp down the said Swamp to Ross road, up the said to the beginning.
15. From Simon Coville along Taylor road to Whiteoak Swamp up the Swamp to Bedford road, up said road to the flat Swamp and down the said Swamp to the beginning.
16. From the mouth of the great Swamp, up the said Swamp to the head, thence along the head of the River Mr. Bailey to the head of Dicks Swamp, then down the said Swamp to the road, up the said road to the mouth of Whiteoak Swamp, up the said Swamp to the beginning.
17. From the mouth of Riddleys branch to the head of Georges branch, down the said branch to Ross road, up that to Rivers branch, down the said branch to the three cricks, down the three cricks to the mouth of the Angelica Swamp, up the same to the beginning.
18. From the mouth of the three cricks, up the same to the mouth of the Branch Swamp, up the same to the County line, down that to Anthony River and down the River to the beginning.
19. From the mouth of Daniel Swamp, up the same to the County line, up said line to the poplar Swamp, down the said Swamp to the three cricks and down the cricks to the beginning.
20. From the mouth of the poplar Swamp, up the same to the County line, up the said line to the three cricks and down the three cricks to the beginning.
21. From the buckhorn bridge up the Swamp to the old Indian line, along the said line to Banks farm road, up the said road to the beginning.
22. From Hunsdalls on the great road at the flat Swamp, down the said Swamp to the mouth of Georges Swamp, up the said Swamp to the road, up said to the beginning.
23. From the Anthony river North Carolina line to the old Annesmond line.
24. Bounded by the old Annesmond line, Black water and Annesmond River.
25. From the lands lying on the east side of St. Georges road lying on the old Annesmond line, thence up the Black water to David Stannards head, up the former side to the aforesaid road.
26. From all the lands of David Stannards on Black water road, up the Poplar Swamp to the road and down the road to the former line.
27. From all the lands on the West side of St. Georges road and up Anthony Swamp to the old parish line, along the said line to the Poplar Swamp and down the same to the road.
28. Between Anthony Swamp, Anthony River and the old parish line.
29. All the lands between Black water and the Poplar Swamp.
30. All the lands from the former parish line, between Black water and branch to Franks bridge down Black creek to Black water.
31. From the old parish line to Broad water road and down the said road to Round Hill Swamp down the same to the beginning.
32. From the broad road up branch to the County line and thence to Black water, and down Black water to the said road.
33. Between Round hill, the light wood and the County line.
34. Between round hill, Black creek the aforesaid and the County line.
35. Between the aforesaid Anthony river and the County line.
36. From the former parish line, thence to the head of Black creek and the aforesaid and down the Swamp to Anthony River, down said river to the former parish line.
37. Between Smiths, Black water and Broad water road.
38. Beginning at the mouth of Dicks Swamp, up that to Ross road, along Ross
