This day this cause came on to be heard by consent of parties on the bill and answer and was argued by Counsel, on the hearing whereof the Court doth order, adjudge and decree that Martha N Vaughan be appointed a Commissioner, who shall after having given due notice of the time and place of sale proceed to sell at public auction to the highest bidder for cash, after having given due notice of the time and place of sale, a negro woman named Mary and her three children belonging to the estate of Anthony Vaughan dec^d and out of the money arising from such sale, after having first paid the expenses attending this decree, the Court doth adjudge, order and decree that one third of the money be allotted to the said Martha N Vaughan in lieu of her life estate, that the sum of four hundred and ten dollars and fifty seven cents be applied to the payment of the due from the said Anthony Vaughan to Martha N Vaughan, and the balance be divided equally between Louisa Jane Vaughan and Shadrack Vaughan children of Anthony Vaughan dec^d and make report to this Court.

This day this cause was docketed by leave of Court and consent of parties and came on to be heard on the bill and answer and was argued by Counsel: On consideration whereof the Court doth order, adjudge and decree that Lewis Worrell the administrator of Josiah Worrell dec^d be authorized to take to the City of Richmond and sell the same in that market, so many of the slaves of his substance Josiah Worrell as will be necessary for the payment of the debts of the estate and make due return thereof before a qualified Commissioner of this Court. And the Court doth further adjudge, order and decree that, Jacob Barrett, Alexander Myrick, Henry Kimbrell and Richard Barrett, be appointed Commissioners of this Court, any three of whom may act, and that they be required after the sale aforesaid to allot to the widow of Josiah Worrell dec^d one full third part of the lands and negroes lately the property of her deceased husband, to be held by her during her natural life, and the other two thirds to the children of Josiah Worrell jointly, and that in making such apportionment regard is
