The Commissioners in this cause this day made their report which is in these words "Agreeably to a decree of the County Court of Southampton dated December Court 1846 we the undersigned Commissioners, in obedience to the requisitions of said decree have laid off ~~for~~ ^{for} ~~Julia A. Worrell~~ ^{Julia A. Worrell} widow of Josiah Worrell dec^d all that part of the tract of land wherein said Josiah Worrell resided, lying on the east side of the little swamp including the mansion house, containing by estimation five hundred and ten acres as her dower in all the lands of her late husband, which said dower land is bounded by the lands of Miles Cook, James Darden, William S. Barrett, Lewis Worrells estate and others - all the balance of the lands of which Josiah died possessed we have allotted to his three children jointly - We have also allotted to the said widow Julia A. C. Worrell as her dower in the slaves of her late husband; exclusive of the five sold by the administrator, the following named negroes, valued as follows, Old Nanny valued at fifty dollars, Harriet & four children, Jacob, Washington, George and one not named seven hundred and fifty dollars, Henry four hundred and seventy five dollars, Amos four hundred and fifty dollars, Anne two hundred and twenty five dollars, Susan three hundred dollars, Jane two hundred and seventy five dollars and child Frank one hundred and twenty five dollars making the sum of two thousand six hundred and forty dollars - The balance of the slaves of said dec^d we have allotted to his three children jointly, names and valuations as follows, old Bob, valued at one hundred dollars, Old Chloe thirty dollars, Cherry two hundred and seventy five dollars, Viney three hundred and fifty dollars, Pat & child Tom four hundred and fifty dollars, Beckey & children Andrew & Nathan five hundred and fifty dollars, Hannah & child Severnack five hundred dollars, Eldridge four hundred dollars, Arthur three hundred and twenty five dollars, Ben three hundred and twenty five dollars, Isham two hundred and sixty dollars, Adolphus one hundred dollars, Leonard fifty dollars, Edy one hundred and thirty dollars, Sarah two hundred and seventy five dollars, Eliza two hundred dollars, Phillis two hundred dollars, Isabel two hundred and fifty dollars and Burnell
