And that said Commissioners make report to Court of their proceedings in order to a final deed.

Ordered that James C. Peters John Williams, Joel Bond and William Bond, a copy thereof being first duly sworn before a Justice of the Peace for that purpose do appearance at the personal estate of Loren Reed dec'd and return the aforementioned under their hands to Court.
