Chamberlain being sworn deponent saith that he is well acquainted with the handwriting of said James M. Williamson, and that said deed having been before proved by the oath of Wm H. French another writing thereof is to be recorded.

The Court proceeded to appoint a forepanel to prosecute for the Commonwealth - the votes of the Court being taken over and stand as follows:

William H. Cobb knowing the smallest number of votes was sufficient and the vote was William J. Goddard of John R. Chamberlain and resulted as follows:

For William J. Goddard the votes were - Nathan D. Bryant, James D. Bryant and P. Nichols, James M. Mayot, Wm C. Pope, Samuel Drury, James J. Ridley, Capt. W. Stevens, James Clayton, N. H. Trull, John Cobb, William M. Nichols, John Cobb, Edwin D. Claude, Thomas Ridley, John Cobb, Jonathan Danaher, Wm. H. Danaher, For John R. Chamberlain the vote was - William A. Chapman, Ben Bowes, P. Nichols, Horace William A. Jones, Mark T. Peete, S. Parker, Robert Bowes and Alonzo M. Nichols, Goodman G. Griffin, Samuel D. Price, Peter J. Holmes, Daniel D. Price, Nathaniel Francis & Henry Price

Cobb etc in due form.
