On consideration whereof the Court doth adjudge, order and decree that Thomas B McCorrell and John C Deale be appointed Commissioners for the purpose of selling to the highest bidder the lands of the late Betty Story upon the following terms - so much cash as may be necessary to pay the costs of this docket - the balance on a credit of nine months - that they take bonds as follows - one bond for one fifth and assign the same to Zachariah Story, one for one fifth and assign the same to John Holt, one for one seventh of one fifth and assign the same to Thomas A Story - one for like amount and assign the same to Benjamin C Daugherty in right of his wife, one for same amount and assign to Eldridge D A Glory in right of his wife, one for same amount and assign Miles Edwards in right of his wife, one for same amount and assign to John D Lyles in right of his wife, one for same amount and assign to Henry Spry in right of his wife, and another for same amount and assign to Samuel Story (heirs of Deft Story) One bond for one third of one fifth and assign the same to William H Wilson, one for same amount and assign to Betty Ferguson, one for same amount and assign the same to Jonathan Dardow guardian of Martha C & Rebecca f Wilson (heirs of Margaret Wilson) one bond for 1/4 of 1/5 and assign to Collet F Story, one for same amount and assign to Elizabeth Williams in right of his wife, one for same amount and assign to George Moore in right of his wife, one for same amount and assign to Elizabeth M Story, one for same amount and assign to guardians of Martha F Story, and one other bond same amount and assign to the guardians of Benjamin F Story - And it is further ordered that the family burying ground and a right of way thereto be reserved - And it is further ordered that the title to the land be withheld till the purchase money is all paid. And said Commissioners are ordered to report to this Court in order to a final decree.
