Ordered that Mrs. C Griffin & J G Jones & A T Stephenson be and they are hereby appointed Commissioners to proceed conjointly with the Commissioners appointed by the County Court of Isle of Wight County, to view Furbells Bridge, and embankment leading thereto, across Black water River. and after giving due notice thereof proceed to let out to the lowest undertaker the repairs that they may deem necessary to be made thereto, that they enter into a written contract with the undertaker, and take bond and security of him according to law conditioned for the faithful performance of the contract and report their proceedings to Court for its ratification or rejection.

It appearing to the Court that Benjamin A James has been erroneously assessed with County taxes to the amount of \$7. 68. on lands for the years 1870 & 1872 It is ordered that he be exonerated from the payment thereof or if paid that it be refunded to him.

Ordered that the Court be adjourned till the first day of the next Term
