Ordnance No. 25. Bounded as follows: From the lands on the east side of Dr. Dorn's road, lying in the old Transumond line, thence up the black water to David Johnson's thence up the Pocahontas side to the aforesaid road.

" " 26. Bounded as follows: From all the land of David Johnson's on black water river, up the Cypress swamp, to the road and down the road to the pocahontas line.

" " 27. Bounded as follows: From all the lands on the west side of Dr. Dorn's road and up Kottaway swamp to the old parish line along the said line to the Cypress swamp and down the same to the road.

" " 28. Bounded as follows: Between Kottaway swamp Kottaway river and the old parish line.

" " 29. Bounded as follows: All the lands between black water black creek, and the Cypress swamp.

" " 30. Bounded as follows: All the lands from the former parish line between black water and seacock, to Frank's bridge, down Black Creek and black water.

" " 31. Bounded as follows: From the old parish line to broad water road, and down the said road to Round Hill swamp down the same to the beginning.

" " 32. Bounded as follows: From the broad road up seacock to the County line, and thence to black water and black water to the said road.

" " 33. Bounded as follows: Between Round Hill the Slightwood and the County line.

" " 34. Bounded as follows: Between Round Hill the Black Creek the Apamossick and the County line.

" " 35. Bounded as follows: Between the Apamossick the Kottaway river and the County line.

" " 36. Bounded as follows: From the former parish line thence to the head of black creek and the Apamossick and down the swamp to Kottaway River, and down said river to the former parish line.

" " 37. Bounded as follows: Between Seacock, Black water, and Broad water road.

" " 38. Bounded as follows: Beginning at the mouth of Dick's swamp up to the Dorn's road, along Dorn's road to the Cypress swamp down that to Kottaway river, up that to the beginning.

" " 39. Bounded as follows: The lands between Seacock, Slightwood and the County line - and

36 Bounded as follows: From the former parish line thence to the head of Black Creek and the Apomacoke and down the swamp to Cottonway River and down said river to the former parish line,

37. Divided as follows: Between Pineville, Blackwater, and Broadwater road.

38. Divided as follows: Beginning at the mouth of Dick's swamp up to the Davis road, along Davis road to the Cypress swamp down that to Cottonway river up that to the beginning.
