Middlesex County of the other part Witnesseth that the said Nathan
Harris West Harris & Daniel Harris for & in consideration of the sum
of eighty Pounds Current Money of Virginia to them in hand paid
by the said Robert Murray before the sealing & delivery hereof the
Receipt whereof the said Nathan Harris West Harris Daniel
Harris doth hereby acknowledge That granted Bargained & sold
& Doth by these presents Grant Bargain & sell unto the said Robert
Murray his Heirs & Assigns forever two certain Tracts or parcels
of Land situate lying & being in the County of Southampton on the
Southside of a Branch called Woreck Branch one tract or parcel of
Land containing two hundred & eighty Acres be the same more
or less it being given to the abovementioned Daniel Harris by
Edward Harris his Father's Will bearing Date 27. Day of April
1733 and bounded as is mentioned in a Patent granted to the said
Edward Harris bearing Date the fourteenth day of November one
thousand seven hundred & thirteen the other Tract or Parcel of Land
containing two hundred & fifty Acres be the same more or less left
to be equally Divided between the said Nathan Harris & West Harris
by Will as aforesaid bearing Date 27. Day of April 1733 and
