 by their being made parties to these presents for and in consideration
 of the sum of twenty five pounds four Shillings Current Money of
 Virginia to the said Trustees in hand paid the Receipt whereof is hereby
 acknowledged Have granted bargained sold entailed and confirmed
 and by these presents Do grant bargain sold entailed and confirmed unto
 the said Etheldred Taylor his Heirs and Assigns forever three hundred
 & sixty Acres parcel of the aforesaid Land and bounded as followeth
 Beginning at three Trees Choise inward to Corner of Major Etheldred
 Taylor's Land thence by the said Taylor's Line NW 196 pole to a Post of NB.
 136 pole to a white Oak a corner of John Thomas's Land thence by the said
 Thomas's Line the same Course 200 pole to a Post then the same Course 160
 pole to three Trees Choise inward to a corner of the said Taylor's Land thence
 by his Line SB 14 pole to a forked Gum S 25° E 72 pole to three Trees Choise
 inward then SW 146 pole to a Red Oak then S 25° W 328 pole to the
