hundred & fifty two Between Richard Hamlin of the County of Southampton of the one part and James Turner Senr of the same County of the other part Witnesseth that the said Richard Hamlin for and in consideration of the sum of forty two pounds seventeen shillings & sixpence current Money of Virginia to him in hand paid by the said James Turner Senr at or before the sealing and Delivery of these presents the Receipt whereof the said Richard Hamlin doth hereby acknowledge; hath bargained & sold and by these presents doth bargain & sell unto the said James Turner Senr one Negro Man Slave called & known by the Name of Sam with the appurtenances of the said Negro Sam to have & to hold the said Negro Man Slave named Sam as above by these presents bargained & sold unto the said James Turner Senr as the proper Negro of him the said James Turner Senr from hence forth forever. Provided always and upon condition that if the said Richard Hamlin his Heirs Executors or Admitors do well and truly pay or cause to be paid unto the said James Turner Senr his Heirs Executors or Assigns on or before the fifteenth Day of May next ensuing the Date of these presents the Sum of forty two pounds seventeen shillings & sixpence current Money of Virginia with lawful Interest thereon without any Deduction or abatement whatsoever; that then this present Indenture and every thing herein contained shall cease determine and be void. And the said Richard Hamlin for himself his Heirs Executors & Admitors doth covenant & grant to & with the said James Turner Senr his Heirs Executors & Assigns that he the said Richard Hamlin his Heirs Executors or Admitors shall & will well & truly pay or cause to be paid unto the said James Turner Senr his Heirs Executors or Assigns the said Sum of forty two pounds seventeen shillings & sixpence current Money of Virginia with Lawful Interest the Day and year aforesaid in Manner aforesaid according to the true Intent & meaning of these presents. And also that he the said James Turner Senr his Heirs Executors Admitors or Assigns shall and may at all times after Default shall be made in performance of the proviso or condition aforesaid peaceably & quietly have hold use occupy possess & enjoy the said Negro Man Slave named Sam to his & their own proper use & uses forever without the let Trouble Hindrance Molestation Interruption & Denial of him the said Richard Hamlin his Heirs Executors or Admitors or of any other person or Persons whatsoever. And the said James Turner Senr for himself his Heirs Executors & Assigns doth covenant & grant to and with the said Richard Hamlin his Heirs Executors & Admitors that he the said James Turner Senr his Heirs Executors or Assigns shall and will immediately upon the Receipt of the said Sum of forty two pounds seventeen shillings & sixpence current Money of Virginia with Lawful Interest at the Day & Time above mentioned deliver or cause to be delivered unto the said Richard Hamlin his Heirs Executors Admitors or Assigns the said Negro Man Slave named Sam which are now received by the said James Turner Senr of the said Richard Hamlin in as good Cast and Condition as the said
