Grant and Sell Alien and confirm unto the said Benjamin Exum his heirs
and assigns forever one certain Tract or parcel of Land lying and being in
the aforesaid County of Southampton containing Three hundred & Twenty acres
and Bounded as will appear by Deeds from the Chief men of the Nottoway Indians
to the said John Exum bearing Date the fifth Day of June one thousand seven
hundred & thirty eight and recorded in Vol of eight County Court Reference
therunto being had will more fully appear also all woods underwoods ways
waters and water Courses and with all profits Commodities and advantages
whatsoever to the same belonging or in any wise appertaining and also the
