And the said Parties being willing & desirous to prevent Disputes & Controversies between them in Relation to the said Estate and to comply with the Law without a Suit in Chancery Now this Indenture Witnesseth that as well for performing the Agreement above mentioned as for and in consideration of the Sum of five Shillings to the said Peter Butts John Butts & Charles Simmons in hand paid by the said Daniel Butts & Sarah Butts at or before the Sealing & Delivery of these Presents the Receipt whereof they do hereby acknowledge and thereof acquit & discharge the said Daniel Butts & Sarah Butts their Exors & Admors They the said Peter Butts John Butts Charles Simmons & Eleanor his Wife Have Remised Released and forever Quitted Claim and by these Presents Do for themselves their Exors & Admors Remise Release and forever quitclaim unto the said Daniel Butts & Sarah Butts and to their Exors Admors & Assigns All and Manner of Right Title Interest Property Claim & Demand whatsoever which they or either of them now have or hereafter may have to the Slaves & personal Estate whereof the said Thomas Butts died seized and possessed And the said Peter Butts John Butts & Charles Simmons for themselves their Exors & Admors Do Covenant Promise & Agree and with the said Daniel Butts & Sarah Butts their Exors and Admors that they the said Daniel Butts & Sarah Butts and their Exors Admors & Assigns and all every or any of them shall from Time to Time and at all Times forever hereafter peaceably & quietly have hold occupy possess & enjoy all the Slaves & personal Estate above mentioned without the Let Trouble Molestation Challenge Claim or Demand of them the said Peter Butts John Butts & Charles Simmons or their Exors Admors or Assigns IN WITNESS whereof the Parties to these presents have hereunto set their Hands and Seals the Day & Year above written
