Gentleman the sum of fifty four pounds ten shillings & six pence being the Balance due to
me by Account Current signed by the said Charles Portlock the tenth Day of October last
more fully appears and also to Ask demand sue for recover and receive of the said Charles
Portlock all such other Sum and Sums of Money Debts and Demands whatsoever which in
any other manner shall appear to be due and owing to me from the said Charles Portlock And
also do appoint and authorize my said Attorney for me and in my Name and to my Use
to Ask Demand sue for recover and receive all such Sum and Sums of Money Debts Goods and
Effects of whatsoever Nature or kind that shall or may be had or found in Virginia
aforesaid that were the property of and did belong to my Brother Charles Jeffreys lately
deceased And to have Use and to have all lawfull ways and means in my Name or otherwise for
the recovery of the said several Sum and Sums of Money Goods and Effects or any or either
of them by Attachment Arrest Distress or otherwise and to compound and agree for the same or
any or either of them and acquittances or other sufficient Discharges for the same or any or
either of them for me and in my Name to Make Seal and deliver and to do all other lawfull
Acts and things whatsoever concerning the premises as fully in every respect as I myself
could or might do if I were personally present Ratifying and by these presents allowing
all and whatsoever my said Attorney shall in my Name lawfully do or cause to be done in and
about the premises by Virtue of these presents In Witness whereof I have hereunto set
my hand and Seal the Twelfth day April in the sixteenth Year of the Reign of Our Sovereign
Lord George the Second by the grace of God of Great Britain France and Ireland King
