This Indenture made this first Day of September one thousand seven
hundred fifty three and in the twenty six year of the Reign of our Sovereign Lord
George the second by the Grace of God of Great Britain France and Ireland King Defender
of the faith &c. Between David Hathaway Jun^r and Jennet his wife of North Carolina
and in Blafford County of the one part and John Pope of Virginia and County of Southampton
of the other part Witnesseth that the said David Hathaway Jun^r & Jennet his wife for and
in consideration of the sum of eighteen pounds Current money of Virginia to them in
hand paid by the said John Pope at or before the inscaling and Delivery of these presents
the Receipt whereof the said David Hathaway and Jennet his wife doth hereby acknowledge
they the said David Hathaway Jun^r and Jennet his wife hath granted Bargained and sold
alliened enfeoffed and confirmed and by these presents doth Grant Bargain and sell allien
enfeoff and confirm unto the said ^{John} Pope his heirs and assigns forever a certain Tract or parcel
of Land containing One hundred & forty five acres more or less Situated lying and being in
Nottoway Parish and county of Southampton and bounded as followeth To wit
Beginning at a white oak corner tree of the said Pope's own old line standing on the
side of Boons branch thence along the line to a pine a corner tree standing on the edge of the
Pocoan thence along that line to a Gum a corner tree standing on the side of
Indian Branch then down the various Courses of the ^{said} Branch to a poplar a corner tree
in the said Branch from thence to a red Oak a corner tree standing in the line
of the said Pope's land and then along Pope's line to the Beginning for one hundred
& forty five acres more or less according to the bounds aforesaid and also all Trees
Woods underwoods commons commons of pastures profits commodities advantages
Emoluments & here disbursements whatsoever to the said land above mentioned belonging
