 will more fully appear. Bounded as follows (viz.) Beginning at a black
 gum acorn tree standing in the wide neck swamp corner of the tract
 and a tract now belonging to Albrighton Jones then he purchased of Edmund
 and others, thence running on Jones line to John Pleagons line to a Hickory
 a corner tree of his tract & Nathaniel Popri thence running on Popri line to a
 sowerwood corner tree of his tract & said Popri thence to the said Robert Thayer
 to a white oak a corner tree of his tract, thence Newes line to William
 Pomeroy & the said William Woodard, line thence the said William Woodard
 line, to a black gum acorn tree in Sore Vicks line, standing in the same
 swamp, thence down the run of the said swamp being a dividing line
 of this tract and the said Sore Vick to a corner tree in or at the mouth
 of the wide neck swamp at John Pleagons line, thence down the s.
 wide neck swamp the dividing line of this tract & John & Elias Pleagon
 to the first Station containing by estimation two hundred & thirty acres

 the said land, tenements, sold & conveyed premises & every part & parcel of

 forever with the reversion and reversion remainder and remainders that
 John & Popri thereof & every part and parcel thereof And the said
 William Woodard & Elizabeth his wife for their selves their heirs and
 assigns, the said land, tenements, and sold premises with every part
 appertaining thereto belonging unto the said Lazarus Cobb his
 heirs and assigns, share & with warranty & power by these presents
 against the lawful claims of their selves their heirs executors &
 administrators, and against the lawful claims of all and every other
 person or persons whatsoever and whomsoever, In Witness whereof
