This Indenture made this 17th day of September in the year
 of our Lord one thousand eight hundred and three, between

 Sinking and Patience his wife for and in Consideration of
 the sum of forty five £ Colours Current money of Virginia by the
 s^d Jonathan Sinking to him in hand paid before the
 sealing and delivery of this indenture the Receipt whereof
 the s^d Benj. Sinking and Patience his wife both hereby acknow-
 ledge and through a quit and discharge the s^d Jonathan Sinking
 doth his heirs and assigns forever and him self therewith fully and
 entirely satisfied Contented and pt. they the s^d Benj. Sinking
 and Patience his wife have granted bargain ed, sold, aliened,
 released, conveyed, set over and delivered & Confirmed & by this present
 doth bargain, sell, alien, convey, release, set over, deliver & Confirm unto
 the s^d Jonathan Sinking and to his heirs and assigns forever, all that
 plantation meadow tract and parcel of Land situate lying &
 being in the County of Southampton Parish afores^d Contain in & by estima-
 tion twelve acres by the same more or less, being the lands that
 Benj. Sinking purchased of Elisha Senior and Willis Brown,
 and bought as by the s^d deed is expressed, and a certain and all the
 houses out houses & appurtenances thereunto ways water & water
 Courses (if any) Commodities hereunto then remaining & remain-
 ing, Issues, and profits thereof, and all the estate Right title
 Interest Claim and demands of them s^d Benjamin Sinking
 Patience his wife, to them and every part and parcel thereof,
 To have and to hold the s^d plantation meadow tract
 & parcel of Land & acres of land & premises with all and every
 the appurtenances as afores^d, unto him the s^d Jonathan Sinking
 and his heirs & assigns forever, and the s^d Benj. Sinking and Patience
 his wife, for themselves their heirs Executors, admors & assigns the s^d plan-
 tation meadow tract and parcel of Land & about of land to the
 same more or less, unto him the s^d Jonathan Sinking & his heirs
 & assigns forever as of him the s^d Benj. Sinking & Patience his wife
 & agt all and every their persons or persons, what so ever (claiming) otherwise
 by the s^d indenture or any part or parcel thereof shall and is so warranted
