thereunto fully and entirely satisfied contented and p^d the s^d Henry Doyal
back, granted, bargained, sold, aliened, released and confirmed and by his hand
1807 with grants, bargain, sell, release, and confirmed unto the s^d Jacob
Barnes and to his heirs and assigns forever, land here of cattle, outbay man,
1 feather be & furniture 1 gun is & other with my house hold and kitchen
furniture & Plantation utensils - To have and to hold the s^d granted articles
