This Indenture made this 12th day of January in the year of our Lord 1814 Between John Barnes and Shadrach Worrell and Lydia his wife of the Parish of Mollisway and County of Dorset of the one part and Micajah Griffin of the same County and Parish of the other Party with that the s^d John Barnes Shadrach Worrell and Lydia his wife for and in consideration of the sum of three hundred dollar good and Law full money of Virginia to them in hand p^d by the s^d Micajah Griffin the receipt where of we the s^d John Barnes Shadrach Worrell and Lydia his wife doth here by acknowledgment on s^d day and a Copy of said Indenture and p^d and there of do Acquitt the s^d Micajah Griffin his heirs & Assigns forever all that Plantation tract or parcel of land and Premises with all the Appurtenances now in the Tenure and Occupation of the s^d John Barnes Shadrach Worrell and Lydia his wife situate lyng and being in the s^d Parish and County on the North side of Black Oak Creek being by Detention one hundred acre (or the same more or less) and bounded as follows. Beginning at a pine a corner in Barnes' bounds line and Rich^d Blackshin's, thence the s^d Blackshin's line to Paul Wiggins line, thence s^d Wiggins line to a corner tree in the long branch up s^d branch to a gum corner Tree of David Bonstaple's line, thence Bonstaple's line to a pine a corner of David Wiggins's line, thence s^d Wiggins's line to Thomas Price Road, thence down s^d road to the fork of Price's and David's, thence down Camp road to the first Station = and all Grounds houses, out houses, Coffersies, Buildings, yards, gardens, Orchards, Truways, waters, watercourses, Pasture, Hamlets, and Appurtenances to the s^d tract or Parcel of land Belonging or in anywise Appurtenant, right, title, interest use, Trust, Possession, Property, Claim and Demand whatsoever of them the s^d John Barnes Shadrach Worrell and Lydia his wife of, to and to the same one and part thereof = To have and to hold the s^d Plantation tract or parcel of land unto the s^d Micajah Griffin his heirs and assigns forever and the s^d John Barnes Shadrach Worrell and Lydia his wife for themselves their heirs & assigns doth here by Covenant promise and grant to and with the s^d Micajah Griffin his heirs & by their Present selves and well lawful heirs defend against all Right, Title, Claim or Demand of any other person or persons claiming or demanding in the same or any part or parcel thereof by this present = In witness whereof we the s^d John Barnes Shadrach Worrell and Lydia his wife have hereunto set their hands and seals this 12th day of January 1814 =
