

185 Trade and Debts in present of *Levi Thorpe*

At a Court held for the County of Southampton the 21st day of May 1804
This Deed of Release was acknowledged by *Levi Thorpe* the party thereof
and ordered to be recorded — — — *Sam^l H. Clegg Esq*

This Indenture made this 19th day of May in the year of our Lord 1804, Between
Seth Jones, late of *Ward*, widow of *Seth Jones* and *Nancy Jones* of the County of Southampton and Parish of *Netley* and *William Jones* of the County and Parish of *Warrington* the said *William Jones* of the one Part and *William Jones* of the County and Parish of *Warrington* of the other Part Witnesseth, that the said *Seth Jones*, late of *Ward* and *Nancy Jones* for and in consideration of the Sum of Three hundred and twenty Dollars to them in hand Paid by the said *William Jones*, the receipt whereof the said *Seth Jones*, late of *Ward* and *Nancy Jones* doth hereby acknowledge have and each of them, hath and by these presents do, and each of them doth grant, bargain sell alien release and confirm unto the said *William Jones* and to his heirs and assigns forever, all that certain parcel of land & Premises with all the appurtenances now in the possession of the said *William Jones* situate lying and being in the County of Southampton and Parish of *Netley* (subject to his mother's dower) containing by Estimation Two Hundred and forty Acres be the same more or less and bounded as follows to wit: Beginning at a *Willow* stump on the one side between *Seth Jones* and *Joseph Denson*, thence along a line of marked trees to a large pine, a corner of *Joseph Denson* and *Joseph Jones* thence along a line of marked trees to a Post oak standing near the run of a *Small* branch, a corner between the said *William Jones* and *John Galt* and *Joseph Jones*, thence crossing the said branch along a line of marked trees to a *Small* Gum standing in the *Willow* thence along a line of marked trees between the said *William Jones* and *John Galt* thence along a line of marked trees to the run of a branch, thence down the *Willow* branch to the fork, thence down *Travellers* branch, to the road thence down the said road to the foot of a large park at the corner of the said *William Jones* thence up the said park to a pine a corner tree between the said *William Jones* and *Seth Jones* and *Nancy Jones* thence along a line of marked trees a north course to the beginning together with all Houses out houses outhouses buildings, yards, gardens, trees, ways, waters, water courses, pastures, common-able hereditaments and appurtenances contained (Subject to his mother's dower and allowance) in the said land belonging or many other appurtenances and the reversions, remainder and remainders unto the said *William Jones* and his heirs and assigns forever, and the said *Seth Jones* late of *Ward* and *Nancy Jones* do hereby solemnly warrant and agree to with the said *William Jones* his heirs and assigns forever
