The Andover made this 11th day of October in the year of our Lord Christ 1873
Between Shadrach Lewis of the County of Hampton and parish of Notaway of the one
part, and Lemuel Lewis of the County and parish aforesaid of the other part, Witnesseth
that the said Shadrach Lewis for and in consideration of the just and full sum of nine
hundred dollars current money of Virginia to him in hand paid by Lemuel Lewis the
receipt whereof the said Shadrach Lewis doth here by Acknowledge and then of
legit and discharge the said Lemuel Lewis his heirs and assigns forever, and himself
thereat fully and entirely Satisfied contented and paid, hath granted, bargained,
sold, aliened, conveyed and confirmed and by these presents doth grant, bar-
gain, sell, alien, release, convey and confirm unto the said Lemuel Lewis his heirs and assigns
forever, All that plantation messuage tract and parcel of Land whereon the
said Shadrach Lewis now lies situate Lying and being in the Aforesaid County
of Notaway and County of Hampton, containing by Estimation one hundred
and thirty Acres be the same more or less and bounded as follows (To Wit) Beginning
at a small black gum standing on the North side of the forty branch in Elisha
Lewis line, Thence the said Lewis Line, to a Turkey Oak on the South side of the said
branch from Jerusalem to the western branch, a corner of Elisha Lewis and Joshua
Lewis, Thence said Lewis line, to a small red Oak, on the South side of Browns
Branch corner of Joshua Lewis and Baker Lewis, thence said line to a black gum standing
on the South side of the cedar Branch, thence the various corners of the said branch
to a corner of Shadrach Lewis and one of Jacob Lewis neighbors and Thence
thence said Shadrach Lewis line to a white oak, thence a line of one acre & two dividing
said Lewis and Lewis corners to a black gum a corner of said Lewis and Browns
Branch, then following the forty branch, Thence up said branch to the first station
where Lewis and Lewis corners buildings woods ways water and water corner of
the boundaries heretofore, whatsoever to the same belonging in any way apper-
taining, and the revision and reversion, remainder and reversionary right of Lewis and
his heirs and all the estate right title and interest of him the said Shadrach
Lewis and to the same and every part thereof, to have and to hold the said
plantation messuage tract and parcel of one hundred and thirty Acres of land of
premises Aforesaid unto him the said Lemuel Lewis his heirs and assigns forever, to the
very proper use and behoof of him the said Lemuel Lewis his heirs and assigns
Lewis and the said Shadrach Lewis for him self his heirs and assigns the said
one hundred and thirty Acres of Land premises with the Appurtenances unto
Lemuel Lewis his heirs and assigns forever, against him the Shadrach Lewis
and his heirs or assigns and against all other persons or person whatsoever
claiming or demanding the same or any part thereof, shall and will
