

This Indenture made this 9th day of December in the year
 four thousand three hundred and four Between Benjamin Drew &
 Wife Mary Drew of Southampton County of the one part and Daniel Pord
 of the other and County of the other part. Witnesseth that the said Benjamin Drew
 and wife for and in consideration of the sum of seven hundred and thirty two dollars
 to them in hand paid by the said Daniel Pord the receipt whereof is hereby
 acknowledged they the said Benjamin Drew and wife have granted sold
 and sold aliened conveyed and by their presents doth grant bargain &
 sell alien convey and confirm unto the said Daniel Pord his heirs and assigns
 forever an certain tract or parcel of Land containing by estimation three
 hundred and thirty nine acres (be the same more or less) situate lying
 and being in the County of Southampton and bounded as follows to wit
 Beginning at a black gum corner in Robert Ricketts line and the mouth of a
 small branch and note rising branch thence along the said Ricketts line S 88°
 W 10 poles as line in the head of the said branch then N 77° W 26 poles then
 S 2° W 26 poles to a pine then South 76° W 79 poles a corner red oak in
 Thomas Woods line and then along said Woods line 37 poles a corner white oak
 in said Woods line then N 26 poles then N 58° E 8 poles then N 70° E 8 poles a
 pine then N 18° E 53 poles a corner black jack then N 60° E 20 poles a
 white oak N 115 poles a corner black gum then N 45° E 7 1/2 poles as line then
 N 92 poles as line then N 15° W 120 poles a corner pine in John Barretts line
 then along said Barretts line S 65° E 92 poles a corner stump in William
 Spicers then then South 6° W 65 poles then N 18 poles a Dead pine a corner
 then S 74° E 54 poles a corner red oak then N 68° E 23 poles N 73° E 8 poles by
 North 71° E 36 poles a corner red oak then S 26° E 100 poles a corner pine
 then S 67° E 100 poles a corner white oak then N 17° E 86 poles a corner
 near the head of the rising branch and then come to the Narrows Creek fork
 rising branch to the same as above or first station and all as above more or less
 more, Commoners Common of pasture for the common of the said Daniel Pord
 and his heirs and assigns whatsoever to the said tract or parcel of Land above
 mentioned belonging or in any way appertaining or in or upon the same
 growing hereafter growing or arising and also the rents and revenues remaining
 and to be received and Issues of the said Land also growing and every part
 and parcels thereof Software and to be let all and singular
 the premises above mentioned with the appurtenances thereto belong-
