doth hereby acknowledge they the said Ethelbert C. Williams & Lucy his
wife have granted bargained & sold alined & confirmed and by these
presents do grant bargain and sell alien and confirm unto the said
Jeremiah Cobb his heirs and assigns forever all that messuage or
tenement situate lying & being in the County of Southampton
