This Indenture made this 16th day of July in the year of our Lord one thousand Eight hundred & eight between Nathaniel Robertson of the County of Southampton and State of Virginia of the first part Jeptha Barrett Esq^r of the Said County and State of the second part and Nathan Williams of the County and State of the third part, Whereas the P^r Nathaniel Robertson doth acknowledge himself Justly Indebted to the Said Jeptha Barrett the sum of one thousand dollars by note bearing even date with these presents and the Said Robertson being willing and desirous to secure the said Barrett the payment Together with legal Interest accruing & also the Cost of drawing recording & carrying into effect these presents Now this Indenture Witnesseth that the Said Robertson in Consideration of the sum of one dollar in hand paid by the P^r Nathan Williams the receipt whereof is hereby acknowledged hath granted bargained & sold & by these presents doth grant bargain & sell unto the Said Nathan Williams his heirs & assigns forever the following Property (to wit) are Negro man Named Moses, also a certain parcel of Land, which was assigned to Patience Simmons (alias) Robertson & held by said Nathaniel Robertson as her Dower in the lands of John Simmons Deed together with the premises and its appurtenances together with all right title & interest they the Said Nathaniel Robertson & Patience his wife has in to the goods mall belonging to the Estate of Said John Simmons Deed also are Copper still & worm, three feather beds & furniture, one Bay Horse Saddle & Bridle, one Chest, one trunk, five sitting Chairs, eight head of cattle, ten head of sheep & eighteen head of hogs, together with all the remainder of my household & Kitchen furniture To have & to hold the aforesaid property unto him the P^r Nathan Williams his heirs & assigns to the only proper use & behoof of the P^r Williams his heirs & assigns forever and the Said Nathaniel Robertson for himself his heirs & executors & administrators doth covenant & agree to & with the Said Nathan Williams that he from time to time forever hereafter will warrant & defend the title of the said property unto him the Said Nathan Williams his heirs & assigns forever (upon special trust & confidence) Nevertheless & to & for the only use intents & purposes following That is to say; he the Said Nathan Williams at any time hereafter whenever he shall be thereto required by either of the parties another sale of the aforesaid property, at public
