This INDENTURE made this 20<sup>th</sup> of April in the year of our Lord one thousand eight hundred and nine between Joshua Whitney Sen<sup>r</sup> and Dolly his wife of the County of Southamptons and parish of Hottoway of the one part and David Whitney of the County and parish aforesaid of the other part — Witnesseth that the Said Joshua Whitney Sen<sup>r</sup> and Dolly his wife for and in Consideration of the sum of One Hundred and Sixty five Dollars Current Money of Virginia to them in hand paid by the said David Whitney the receipt whereof the said Joshua Whitney and Dolly his wife doth hereby acknowledge themselves fully and amply satisfied and pass hath granted, Bargain & sold, aliened, enfeoffed, & confirmed and by these presents doth grant, bargain and sell unto the said David Whitney, his heirs and assigns forever one certain tract or parcel of Land and premises situate & being in the County and parish aforesaid containing by Estimation One Thousand and Sixty five acres to the same more or less, and bounded as follows (To wit) Beginning at the mouth of Eley's Branch at the run of the Swamp thence down the run of the said Swamp to the mouth of the Gum Pond, thence up the said pond to Mills Lawrence & Joseph Ballards lines thence along their lines to Richard Royals dec<sup>d</sup> & Joseph Ballard's corner standing on the aforesaid Eley's Branch. Thence down the run of the said Branch to the first Station — And all houses out houses, Edifices, buildings, yards, gardens, orchards, ways, waters, & watercourses, to the said tract, or parcels of Land, belonging or in any wise appertaining and all right title, Claims, Claims on Demands, whatsoever of them the said Joshua Whitney & Dorothy his wife of and to the same and every part or parcel thereof — To have and to hold the said tract or parcel of Land unto the said David Whitney, his heirs and assigns forever and the said Joshua Whitney and Dorothy his wife for themselves their heirs exec<sup>d</sup> and assigns doth hereby covenant promise and grant to & with the said David Whitney, his heirs & assigns by these presents shall and will warrant and forever defend the said Land unto the said David Whitney against the right title claims on demands of any persons or persons claiming an interest in the same or any part or parcel thereof — In witness whereof the said Joshua Whitney Sen<sup>r</sup> & Dorothy his wife hath hereunto set their hands & affixed their seals this day and year within written —
