This Indenture made this 20<sup>th</sup> day of March in the year of our Lane  
one thousand eight hundred and nine between Jacob Vick of Southampton County  
Virginia of the one part and Isaac M. Knop of the same County and State of  
the second part - Witnesseth that the said Jacob Vick for and in consideration  
of the sum of fifty two and two thirds Dollars to him in hand paid by him  
the said Isaac M. Knop the receipt whereof is hereby acknowledge hath granted  
bargained and sold and by these presents doth grant bargain and sell unto  
him the said Isaac M. Knop a certain piece parcel or tracts of land lying &  
being in the County of Southampton and on the South side of Nottoway River and  
bounded as follows to wit Beginning at a white oak a corner in the line of John  
Jackson dec<sup>d</sup> thence South Seventy Degrees west 142 Pole to an oak stump a corner  
in the line of Mills Everett dec<sup>d</sup> thence South 40 Degrees east 66 pole along  
the line of the said Everett to a pine on the <sup>222</sup> main road leading from  
the Piney Grove to the Cypress Bridge thence north 50 Degrees East 114 pole down  
the said road to a pine in the line of the said John Jackson dec<sup>d</sup> thence north 60  
Degrees west 8 Pole to the beginning containing by Estimation Twenty <sup>2 1/2</sup> Acres  
more or less - To have and to hold the said Land and appurtenances to  
him the said Isaac M. Knop his heirs and assigns forever and he the said  
Jacob Vick for himself his heirs and assigns the said Land and premises &  
every part and parcel thereof against all and every other person or persons what-  
soever or whosoever doth and shall <sup>in and by</sup> forever Defend clear of all Incumbrances -
