

paid by the said Samuel Jones at or before the enrolling and delivery of these presents, the receipt of which is hereby acknowledge, hath granted, bargained & sold conveyed, aliened, and confirmed, and by these presents doth grant bargain sell convey, alien and confirm, unto the said Samuel Jones all the personal property of which nature or kind soever belonging to the said Elisha Lewis, and describe as follows, to wit, One Sowel mare bridle and saddle, nine Cattle, twenty Hogs, six sheep, thirty Barrells Corn, boops of fodder, cotton and flax, one cart wheels & gear, two plow frames, three plow hoes, four weeding hoes, three grubbing hoes, one spade, one foot axe, two, Chisels, one spade, three Augers, one hand saw, one drawing knife, two pair stellyars, one Flap rake and hachle, four feather beds and furniture, one walnut Desk, one walnut Chest of drawers, three walnut Tables, one pine Table, six Windsor Chairs, Eight walnut frame Chairs, four maple Chairs, three trunks, two looking glasses, two pair hand Irons, one pair brass Candle sticks, one pair Smoothing Irons, & Gird, two pewter dishes, three pewter basons, seven pewter plates, six earthen Dishes, twelve Earthen plates, one Dozen Cups & saucers, one Coffee pot, three bowls, one large Canaster, two large waters, one small tetter six Silver Tea spoons, one Dozen Pewter Table spoons, two spinning wheels, three pair Cares, three stone jugs, four stone pots, one Gun, two Iron pots, one Dutch oven, one Tea Kettle & trivet, one frying pan, one grid Iron, one bellmettle Kettle, four pales, and three Tubs, To have and to hold the said main, Cattle & sheep, hogs, Corn, fodder, cotton & flax, plantation utensils, household and kitchen furniture as above described, unto him the said Samuel Jones his heirs, exors & acnts and assigns forever and the said Elisha Lewis, for himself his heirs exors & acnts the titles to the aforesaid property, unto the said Samuel Jones, doth hereby power warrants and defend against the lawfull Claim or Claims of him the said Elisha Lewis his heirs exors & acnts and assigns and of all and of every other person or persons whatsoever.
