 county of the other part: Witnesseth that the said William Judkins and  
 Peggy Judkins his wife, Sam'l W. Judkins and Betsy Judkins his wife, hath  
 for and in consideration of the sum of seventy-eight pounds Virginia  
 currency to them in hand paid by the said Henry D. Juman the receipt whereof  
 they the said Williams Judkins and Peggy his wife Sam'l W. Judkins and Betsy  
 his wife doth hereby acknowledge, that the said William Judkins and Peggy  
 his wife Sam'l W. Judkins and Betsy his wife, hath granted bargained & sold  
 alined and confirmed and by these presents doth grant, bargain sell alien &  
 confirm unto the said Henry D. Juman a certain parcel of land contain-  
 ing by a late survey forty-five & 3/4 acres and bounded by the lands of  
 Richard Edwards Gray, Judkins and Lemire Bailey and James Lancaster  
 and seat with the appurtenances, remainder and remainders thereto  
 and series of the said premises, and every part thereof, and also all  
 the estate, right, title, interest, claim and demands whatsoever of them  
 the said William Judkins and Peggy his wife, Sam'l W. Judkins and  
 Betsy his wife, of in and to the said premises and every part and  
 parcel thereof; to have and to hold all and singular the said land  
 and premises above mentioned, and every part and parcel thereof, with  
 the appurtenances unto the said Henry D. Juman his heirs and  
 assigns to the only proper use and behoof of him the said Henry  
 D. Juman his heirs and assigns forever and the said William Judkins  
 and Peggy his wife Sam'l W. Judkins and Betsy his wife for themselves  
 their heirs the said land and premises and every part thereof against  
 them their heirs, and against all and every other person & persons whatsoever,  
 their heirs and assigns and forever before unto the said Henry D. Juman  
 his heirs and assigns forever. In witness whereof the said William
