Solemnization of the said Intended Marriage and to be allotted to her or to
her use and benefit in pursuance and by virtue of the said last will
and testament— To have and to hold as soon as the same shall be
allotted as aforesaid the said third part of the slaves whereof the said
Henry Briggs died die possessed, the said Negro boy slave named
Mike and the said third part of the other personal estate remain-
ing at the time of the Solemnization of the said Intended Marriage
and all the right title, interest & estate whatsoever of the said Emily Briggs
of in or to the said slaves and other personal estate of them the said
Nathaniel Pierce and Rice Bolton Pierce their executors, administrators
and assigns upon such trust nevertheless, (and to and for
such intents and purposes as are herein after mentioned) as before
and declares of and concerning the same that is to say— In trust
for the said Emily Briggs according to her estate and interest
therein at the time for immediately before the execution of these
present, untill the Solemnization of the said Intended Marriage: And
from and after the Solemnization of the said Intended Marriage
then upon trust that they the said Nathaniel Pierce and Rice
Bolton Pierce their executors, administrators and assigns shall and
do permit the said Spencer Pierce during the joint lives of them
the said Spencer Pierce and the said Emily Briggs, his Intended,
wife to receive take and enjoy the possession and all the issues
profits hires and other emoluments whatsoever of all (and singular)
the before mentioned Slaves, as well of the third part of the slaves
whereof the said Henry Briggs die possessed and to be allotted as aforesaid
on of the Negro boy slave named Mike before mentioned, and also
that they the said Nathaniel Pierce and Rice Bolton Pierce, shall
and do permit the said Spencer Pierce, during the joint lives of them
the said Spencer Pierce and the said Emily Briggs, his Intended wife,
in like manner to have receive take and enjoy the possession and all
the issues profits and other emoluments whatsoever of the aforesaid third
part of the other personal estate, remaining at the time of the solemn-
ization of the said Intended Marriage, the possession and profits of
all and singular of the said slaves and of the said third part of
the other personal property to be enjoyed by the said Spencer Pierce during
the joint lives of them the said Spencer Pierce and the said Emily
Briggs, for his own use and benefit: and from and after the decease
of either of them the said Spencer Pierce and the said Emily Briggs
