

This Indenture made this 2nd day of November in the year of our Lord
 Christ one thousand eight hundred and sixteen between Henry Thomas and Zacheus
 Story Commissioners of the County of Southampton and Parish of Saint Luke
 of the one part and George Gurley of the same County and Parish of the
 other part Witnesseth that the said Henry Thomas and Zacheus Story
 Commissioners for and in consideration of the sum of one hundred and
 fifty dollars good and lawful money of Virginia to them in hand paid
 by the said George Gurley the receipt whereof the said H^y Thomas and
 Zacheus Story as aforesaid doth acknowledge themselves fully and amply
 satisfied and that both granted bargain and sold aliened Enfeoffed and
 confirmed and by these presents doth grant bargain and sell unto the
 said George Gurley his heirs or assigns forever one certain tract or piece
 of land and premises being lot N^o 4 of the division in the lands of
 Benjamin Edwards deceased situate lying and being in the County and
 Parish aforesaid Containing thirty acres be the same more or less and
 bounded as follows to wit Beginning at a red oak a new corner made in
 lots N^o 7 and 8 standing on the side of the road thence along the said
 50 pole to a new corner made in lots N^o 5 and 7 thence along
 the dividing line of lots N^o 4 and 5 S 31° E - 80 pole to the lower corner
 of the fence that runs down to a branch thence S 45° W 30 pole to
 a new corner made in the out bounds of lots N^o 3 and 4
 N 69° W 75 pole to the road aforesaid and from thence along the said
 road to the first station together with all houses out houses 20 acres
 buildings yards gardens orchards ways and watercourses whatsoever belong-
 ing or in any wise appertaining To have and to hold the same unto
 the said George Gurley to him and his heirs forever unto the said
 Henry Thomas and Zacheus Story as aforesaid for themselves their heirs
 executors and administrators doth by these presents Covenant & grant
 to & with the said George Gurley his heirs and assigns that they will
 by these presents well warrant and defend as Commissioners
 In Witness whereof the said Henry Thomas and Zacheus Story both here-
 set their hands and affixed their seals this day and date as within
 written
