This Indenture made and entered into on this 18th day of September
1815 by and between Spencer Pierce of the first part John Thomas of the
second part and Rice Pierce Nathaniel Pierce John Rockelle Clements
Rockelle James Rockelle and Griffin Stith of the third part of all of the
County of Southampton and state of Virginia whereas the said Rice Pierce
Nathaniel Pierce John Rockelle Clements Rockelle James Rockelle and Griffin
Stith are bound as securities for the payment of a considerable part of
a debt due and owing from the said Spencer Pierce to John Denegre
and the said Spencer Pierce is willing and desirous to save them harmless
in that behalf now therefore this Indenture witnesseth that the said
Spencer Pierce for and in consideration of the premises but more especially
for and in consideration of the sum of one dollar to him in hand paid
by the said John Thomas at and before the sealing and delivering of these
premises the full receipt whereof is hereby acknowledged and from every part
of which the said John Thomas his executors administrators and assigns
the following property to wit Twenty head of hogs twelve head of cattle
one with other three horses ten head of sheep six beds and furniture
fere walnut Tables one Desk one bedstead and furniture two riding
Chairs and Harness one and a half dozen Windsor Chairs one walnut
Chest To have and to hold all the said property to him the said John
Thomas his executors administrators and assigns to the only proper use and
 behoof of him the said John Thomas his executors administrators & assigns
but upon this special trust and confidence nevertheless that if the said
Spencer Pierce his heirs executors or administrators shall fully content & satisfy
the said John Denegre by the payment of the debt aforesaid with the
interest accrued and accruing thereon so that his aforesaid securities have no
part thereof to pay then this Indenture is from henceforth to be void &
of no effect and the said John Thomas is to release to the said Spencer
Pierce all the right title interest and estate in the said property hereby
