This Indenture made this 20th day of November in the year of our
one thousand eight hundred and fifteen between Nathaniel Barham and Nancy
his wife of Southampton County of the one part and Benjamin Wrenn of the same
County of the other part Witnesseth that the said Nathaniel Barham and Nancy
his wife in consideration of two hundred and fifty dollars of lawful money
of the Commonwealth to them in hand paid by the said Benjamin Wrenn at
or before the sealing and delivery of these presents the receipt whereof is
hereby acknowledged have bargained and sold & by these presents do bargain
sell unto the said Benjamin Wrenn his heirs and assigns a certain tract or
parcel of land lying and being in the aforesaid County of Southampton
Containing sixty acres be the same more or less and bounded as follows
beginning at a pine stump a corner in James Barham and said Benja-
min Wrenn line and said land thence along said Wrenn line to a hickory
corner of Wilkerson Capello line to a hickory afore and aft thence to a
red oak a few & aft thence to a scrubby oak afore & aft then a straight
line to a cypress state a corner in James Barham & Wilkerson
Capello lines & said line thence a straight line to a pine afore & aft,
thence by a line of marked trees to the beginning together with all the
reversions and reversions remainder & remainders yearly and other rents issues
and profits thereof and of every part and parcel thereof. To have & to
hold the lands with the tenements hereditaments & all and singular
other the premises herein before mentioned or intended to be bargained & sold
and every part and parcel thereof with every of their rights liberties &
appurtenances unto the said Benjamin Wrenn his heirs & assigns forever
and the said Nat Barham and Nancy his wife for themselves and
their heirs the said land with all and singular the premises and appurtenances
before mentioned unto the said Benjamin Wrenn his heirs and assigns
free from the claim or claims of them the said Nat Barham and
Nancy his wife or either of them their or either of their heirs and assigns
every person or persons whatsoever shall will and do warrant defend
defend by these presents In Witness whereof the said Nat: Barham
& Nancy his wife have hereunto set their hands and seals the day &
