This Indenture made this 9th day of February in the year of our lord one
thousand eight hundred and sixteen between Henry Enman, Rebecca his wife of
Southampton County of the one part and Byrd Hamwell of the same County of
Hamwell the other part Witnesseth that the said Henry and Rebecca in Consideration
and delivery of the sum of one thousand three hundred and twenty dollars to them in hand
paid by the said Byrd Hamwell and his heirs have given granted bargain
and sold and by these presents do give grant bargain and sell unto
the said Byrd Hamwell and his heirs full right of a plantation which
Jordan Haskins did and seized and possessed being that part of which I
purchased of William Jenkins Samuel Jenkins Gray Jenkins and
Henry Jenkins reference being had to their deed well fully appear-
containing by a late survey one hundred and thirty two acres be the
same more or less lying on the south side of Little swamp and is bound
by the lines of Joshua Brellow Johnson Wilefox Byrd Hamwell and
George Bally To have and to hold the said tract or parcel of land
with its appurtenances to him the said Byrd Hamwell of his heirs and the
said Henry Enman and Rebecca his wife for themselves their heirs
