

This Indenture

This Indenture made this 1st day of
 January in the year of our Lord one thousand eight hundred and seventeenth
 between James Bechelle of the town of Jerusalem and County of Southampton
 of the one part and David Vallance of the same town and County of the
 other part Witnesses that the said James Bechelle for and in consideration
 of the sum of fourteen hundred dollars to him in hand paid at and before
 the sealing and delivery of these presents the receipt whereof the said James Bechelle
 doth hereby acknowledge and thereof and of every part thereof doth hereby exonerate
 and discharge the said David Vallance His heirs executors & administrators he the
 said James Bechelle have granted bargained sold aliened enfeoffed and confirmed and
 by these presents doth grant bargain sell alien enfeoff and confirm unto the said
 David Vallance His heirs and assigns forever a certain tote of land lying situate
 and being in the town of Jerusalem and County aforesaid and known & distinguished
 shew in the plan of the said town of Jerusalem by lot N^o 5 and bounded as
 follows beginning at the South East Corner of lot N^o 4 on the West side of
 the main street thence along the main street ninety feet four inches to the Cross
 street thence along the cross street two hundred and thirty seven feet nine inches
 to the corner of lot N^o 6 thence on the line of lot N^o 6 ninety feet four inches to the
 Corner of lot N^o 4 thence binding on lot N^o 4 two hundred and thirty one feet
 nine inches to the beginning also a part or parcel of a certain lot of land
 lying situate and being in the said town of Jerusalem and known & distinguished
 ished in the plan of the said town of Jerusalem by N^o 6 bounded as
 follows beginning at the South west corner of lot N^o 5 on the North side of the
 Cross street thence along the line of lot N^o 5 ninety feet four inches to the corner of
 lot N^o 4 thence South seventy six degrees West to a large pine standing near
 the river thence down the river to the cross street thence along the North side
 thereof belonging or in any wise appertaining and the reversions and reversions
 remainders and remainders and all benefits issues and profits of the said lands
 and premises and all its rights title and interest to the same To have and to
 hold the said lot N^o 5 and the above described parcel or part of lot N^o 6 and
 the premises unto the said David Vallance His heirs and assigns forever to the
 use proper use and behoof of him the said David Vallance His heirs & assigns
 and the said James Bechelle doth hereby covenant and agree to and with the
 said David Vallance that he the said James Bechelle His heirs and every of them
 shall and well forever warrant and defend the right and title in and to the
 said lot N^o 5 and the said parcel or part of lot N^o 6 and every part and parcel
 thereof with all and singular the appurtenances thereto belonging unto the said
 David Vallance His heirs and assigns forever against the claim or demand of
 him the said James Bechelle and his heirs and every other person whatsoever
 In Witness whereof the said James Bechelle hath hereunto set his hand and
 affixed his seal the day and year above written
