This Indenture, made this seventeenth
 day of May, in the year of our Lord one thousand eight
 hundred and seventeen, between Joel Nervum of the
 first part, and Nancy Maggett, a trustee specially
 appointed of the second part, and Nancy Nervum, Elizabeth
 Williams, Julia Beal, and Nervum Lucy Nervum, and
 Sally Nervum, children of the said Joel Nervum, and
 Simon Everett Nervum, William Henry Nervum, and
 Mary Ann Nervum, children of David Nervum, of the
 third part, to the said Simon Everett Nervum, William
 Henry Nervum, and Mary Ann Nervum, the said Nancy
 Maggett, to pay one hundred and twenty dollars out of
 the property herein mentioned. This deed witnessed that
 the said Joel Nervum for and in consideration of the love,
 good will and natural affection, which he bore and bear
 unto the said Nancy Nervum, Elizabeth Williams, Julia
 Beal, and Nervum, Lucy Nervum, and Sally Nervum his
 children, and also for the sum of forty dollars, current money
 to him in hand paid by the said Nancy Maggett, the re-
 ceipt whereof the said Joel Nervum doth hereby acknowledge
 he the said Joel Nervum hath given, granted, bargained,
 sold, aliened, conveyed, released, and confirmed, and by these presents
 and by these presents, doth give, grant, bargain & sell, alien,
 convey, release and confirm unto the said Nancy Maggett his
 heirs, executors, administrators and assigns, all that tract or
 parcel of land, lying and being situated in the County of
 Southampton containing by estimation one hundred and
 fifty nine acres & a half, being the same land whereon
 the said Joel Nervum now resides; Also two Negro namely,
 Rod, Amor, Lucy, Julia, Nat, Mary, Junr, Mason, Jany and
 Davis, also two horses, eleven head of Cattle, also five sheep
 all the stock of hogs, house hold & kitchen furniture, plan-
 tations utensils, together with every other part of my property
