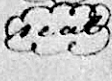


Beal & Co

Jordan

This Indenture, made this 11th day of March
 the year of our Lord Christ, one thousand eight hundred and
 something, between Jordan Beal & Elizabeth his wife both of the
 County of Southampton & Parish of Wottonray of the one part and
 Henry Jones of the same County and Parish of the other part
 Witnesses, that the s^d Jordan Beal & Elizabeth his wife for
 and in consideration of the sum of one hundred and forty dollars
 good and lawful money of Virginia, to him in sh^{ts} and paid
 by the said Henry Jones, the receipt whereof the s^d Jordan
 Beal & Elizabeth his wife acknowledged themselves fully and
 amply satisfied and paid, hath granted, bargained, sold, aliened,
 conveyed and confirmed; and by these presents doth grant, bar
 & give, sell unto the said Henry Jones, to him and to his heirs
 forever, all that tract or parcel of Land and premises to him
 and to his heirs forever, situate, lying & being in County & Parish
 aforesaid, and beginning the two hundred acres that the s^d Jones
 purchased of the said Beal, formerly containing by a late survey
 made by the County Surveyor Twenty one and one half acres to
 the same more or less, and bounded as follows, (To wit) beginning
 at a black gum standing in the long branch a new corner
 in Jordan Beal's line, thence along a small branch N 73° W
 18 pole, thence N 12, W 24 pole to a post oak, thence N 23. W
 76 pole to a small pine a new corner made in Beal's line, thence
 N 63, W 18 pole to a pine a new corner made in Henry Jones
 line, thence S 6. E 13 1/2 pole to the long branch aforesaid, and
 thence along that branch the various courses thereof to first
 station; and all houses, out houses, buildings, yards, gardens,
 orchards, ways, waters and water courses wh^{ts} & over belonging
 or in any wise appertaining to the said tract or parcel of
 Land and premises. To have and to hold the same unto the
 s^d Henry Jones to him and to his heirs forever, and the said Jordan
 Beal and Elizabeth his wife, for themselves their heirs, Executors
 or assigns, doth by these presents covenant and grant to and with
 the s^d Henry Jones his heirs and assigns, that ^{they} will warrant and
 defend all right, title, claim or demand of any person or persons
 claiming the same or any part thereof. In Witness whereof
 the said Jordan Beal & Elizabeth his wife hath hereunto set
 their hands & affixed their seals this day and year first
 written.
