This Indenture made this 12th day
of December in the year of our Lord, first one thousand and eight
hundred and sixteenth, between Jesse Council of the County of
Southampton and Parish of Stollonay of the one part, and Joseph
Harris of the same County and Parish of the other part, Witnesseth
that the said Jesse Council for and in consideration of the sum
of Seventy three dollars & thirty seven & 1/2 cents good and lawful
money of Virginia to him in hand paid by the S^r Joseph Harris
the receipt whereof the S^r Jesse Council doth acknowledge himself
fully and amply satisfied & paid, have granted bargained, sold
allotted, conveyed and confirmed, and by these presents doth
grant, bargain & sell unto the S^r Joseph Harris to him and
to his heirs forever, one certain Tract or Parcel of Land and premises,
Situate, lying and being in the County and Parish aforesaid, and
on the North East Side of Nancy Atkinsons Mill Pond, containing
by a late survey made by the County Surveyor, thirty one acres and
three fourths, to the same more or less, and bounded as follows (To
Wit), Beginning at a Point on the edge of an old field, corner
made in Joseph Harris's line, thence S 45° W 85 1/4 poles
to a black gum a new corner made in Jesse Council's line, on the
edge of Nancy Atkinsons Mill Pond, thence S 17° E 43 1/4 poles to a
spruce a new corner made in Nancy Atkinsons line near the mill
Pond, thence N 62° E 20 poles variation on the line, thence N 55°
E 40 poles, thence N 41° E 38 poles, thence N 57° E 22 poles to a
light wood post a ft. of Joseph Harris's line, thence N 59° W 30
poles to the first station, Together with all houses, out houses,
edifices, buildings, yards, gardens, orchards, mays, water and water
courses whosoever belonging or in anywise appertaining to
the said Tract of Land. To have and to hold the same unto
the S^r Joseph Harris his heirs or assigns forever and the said
Jesse Council for himself his heirs, Executors and assigns doth by
these presents covenant and grant to and with the S^r Joseph
Harris his heirs, Executors and assigns that he will warrant
and defend all the right title, claim or demand of any person or persons
claiming or demanding the same or any part or parcel thereof. In
