 red oak stump a corner of Jordan Edwards and Benjamin Beals thence
 along Jordan Edwards line to a red oak a corner of Jordan Edwards
 thence along Jordan Edwards line to a small Sweet Gum standing
 in the Coney Branch a corner of said land and William Williams
 land, thence down the run of said branch to a black gum stand-
