aliened, conveyed & confirmed, and by these presents doth grant, bargain
& sell, unto the said Mr. Moore to him & his heirs forever, One certain
tract or parcel of land & premises, situate, being & lying in the
County Parish of said, Containing by a late survey made by
the County Surveyor, Twenty acres & 3/4, be the same more or less
be more as follows, to wit, Beginning at the intersection of the
white oak branch of the road leading from Blackwater Creek
to Jerusalem, thence N 38. W 36 pole variations on the branch, thence
N 47. W 36 pole to the corner of Mr. Moore & Polly Barnes's grand daughter

pole to a small dog wood, a corner of Mr. Moore's matting house, thence
S 43. W 36 pole to a small pine, at the N. of the new school house
or of the same matting house, thence S 45. E 46 pole to the road above
thence S 42. W 46 pole to the first station; to go along with all houses,
out houses, edifices, buildings, yards, gardens, orchards, ways, waters,
& water courses whatevers, & don't give or in any wise appertaining
