made thirteenth day of April in the year of our Lord one thousand eight hundred and fifty eight, between Jacob Porter and Matthew Porter his wife, Penny Porter, Polly Jones, and Council Nick son & Edith Nick his wife of the one part, and Joseph Pope of the other part and all of the county of Southampton state of Virginia. Witnesseth that the said Jacob Porter and Martha his wife, Penny Porter, Polly Jones and Council Nick son & Edith Nick his wife for and in consideration of the sum of one thousand dollars to them in hand paid by the said Joseph Pope at or before the sealing and delivery of these presents. The receipt whereof the said Jacob Porter and Martha his wife, Penny Porter, Polly Jones, Council Nick & Edith his wife doth hereby acknowledge, have bargained, sold alied and confirmed unto the said Joseph Pope his heirs & assigns forever one certain tract or division of land lying & being situated in the county of Southampton & being on the South side of Mattaponi river, and containing by estimation one hundred & thirty and two third acres of land, be the same more or less, being out proportionable parts of the land formerly belonging to James Porter deceased and bounded as followeth. To wit. Beginning at Crafford's road, at a red oak, a corner tree between Nathaniel Rochelle and the said Porters land, thence along the said Rochelle's line, to a branch, thence down the branch between Rochelle's said land, to the Fox matt. Hounds swamp to Richard B Days line, thence along the various courses of the swamp adjoining Richard B Days line & John Barnes's line, to John Popes line, thence along a line of marked trees, between John Popes & the said Porter land to Matthew Toyner's line, thence along Toyner's line to John Popes line, thence along John Popes line to Crafford's Road, to Hanson Popes line, thence up the said Road, to the first beginning together with the reversion and reversionary remainder and remains rents, issues, profits & services of the said land and premises and likewise all the estates, right titles, interest, property, claim and demand whatsoever of the said Jacob Porter & Martha his wife, Penny Porter, Polly Jones & Council Nick & Edith his wife, of and to, the said land & premises and every part and parcel thereof, to have and to hold the said land and premises, with the appurtenances, unto the said Joseph Pope his heirs and assigns forever, to the only proper use and behoof of him the said Joseph Pope his heirs and assigns forever, & the said Jacob Porter & Martha his wife, Penny Porter, Polly Jones, Council Nick son & Edith his wife, shall and will warrant and forever defend the said bargained premises, against themselves & their heirs assigns forever.
