Carolina of the one part and Joseph Pope of the County of Southampton and State
of Virginia of the other part Witnesseth that the said Eli Wick Martha
his wife John Daniel Pissella his wife Peter Rimes Anna his wife Sally
Roper for in consideration of the sum of two hundred & forty Dollars to them in
hand paid by the said Joseph Pope at & before the signing & delivery of these
premises the receipt whereof the said Eli Wick Martha his wife John
Daniel Pissella his wife Peter Rimes Anna his wife and Sally Roper
both being and being confirmed unto the said Joseph Pope his heirs and
assigns forever a certain tract or dividend of Land situate lying and being in
the County of James and State of Virginia containing by estimation
thirty two acres & two thirds of an acre be & the same more or less it being
our proportionable parts of the land formerly belonging to James Pope dec^d
and bounded as followeth to wit beginning at Grantsford road at a corner oak
a corner tree between Nathaniel Richells & the said Potters land thence along said
Richells line to a branch thence round the various courses of the branch between
Richells & the said Potters land to the Townshursts swamp to Rich^d B. Days
line thence along the various courses of said swamp a joining Rich^d B. Days
line & John Barnes's line to John Pops line a corner tree in the swamp thence
along a line of marked trees between John Pope & the said Potters Land to
Matthew Spencers dec^d line thence along Spencers line to John Pops line
thence along John Pops line to Grantsford road to Hanson Pops line thence up
the said road to the first beginning together with the various meadows, meadows
and remainders rents issues profits & services of said land & premises likewise all
the estate rights title interest property claim & demand whatsoever of the
said Eli Wick Martha his wife John Daniel Pissella his wife
Peter Rimes Anna his wife and Sally Roper of or and to the said
land & premises & wing part & parcel thereof to have & to hold the said land and
premises with all appurtenances unto the said Joseph Pope his heirs and assigns
