This Indenture made this 15th day of November in the year one thousand, eight hundred and nineteen between Britton Barnes & Rachael Barnes his wife of the County of Northampton and State of North Carolina of the one part and Richard Darden of the County of Northampton State of Virginia of the other part Witnesseth that the said Britton Barnes and Rachael Barnes his wife for and in consideration of the sum of one thousand six hundred and twenty four dollars and fifty Cts to them in hand paid before the enclosing and delivery of these presents the receipt whereof is truly acknowledged, have granted, bargained and sold and by these presents doth grant, bargain (and sell unto the said Richard Darden his heirs and assigns forever one certain tract or parcel of land lying and being in the County of Northampton State of Virginia, containing by estimation three hundred and sixty acres the same more or less land bounded as follows to wit beginning at a millery tree on the road leading from Jerusalem to the cross Keys a corner of Simon Pope and John Carr thence S 45° or 160 pole to a black Jack a corner of Simon Pope thence S 45° or 160 pole to a pine a corner of Jacob Williams thence S 45° or 136 pole to a sonnet pine a corner of Ethelred Edmunds Nathan Pope and Tally Williams thence south 49° East 273 pole to a degree a corner of Nathan Pope standing in his cornfield thence south 88 degrees west 28 pole variation on the line thence south 54° west 67½ pole to a oak a corner of Thomas Newsum thence along Newsums line south 19° east 126 pole to a pine a c. of Thomas Newsum thence south 68° east 140½ pole to a larger post oak a corner in Newsums line thence East 87° east 17 pole to a pine a corner of Thomas Newsum thence East 43° east 89 pole to a hickory a corner of Newsums line thence East 49½ west 54 to a hickory a c. of Thomas Newsum thence 120 east 20 pole to the branch parted the gifford branch thence down the branch the various courses thence to the road a p. thence along the said road S 38° east 27 pole to the beginning of it being the land on which the said Barnes formerly lived &c. &c. have and to hold the said tract or parcel of land aforesaid with all and singular the appurtenances therunto belonging to the only proper use and behoof of him the said Richard Darden his heirs and assigns forever and the said Britton Barnes & Rachael his wife for themselves their heirs, executors and assigns the right and title to the said tract of land unto the said Richard Darden his heirs and assigns against the claim of themselves or against the claim or pretensions of any other person or persons whatsoever shall hereafter make out and defend by these presents in witness whereof the parties have hereunto set their hands and affixed their seals the day and year above written signed sealed acknowledged and delivered in presence of
