This Indenture

25th day of July one thousand eight hundred and nineteen ^{made this}
Nathan Edwards and Seditah's wife of the County of Southampton
State of Virginia of the one part and Lewis Morrell of the same
County and State of the other part, Witnesseth that the said Nathan
Edwards and Seditah his wife for and in consideration of the
sum of one hundred dollars to them in hand paid by the said
Lewis Morrell at or before the sealing and delivering of these
presents the receipt whereof the said Nathan Edwards & Seditah's
wife doth hereby acknowledge and thereof acquit & discharge
the said Lewis Morrell his heirs executors and assigns forever by these
presents they the said Nathan Edwards & Seditah his wife have
granted bargained, sold, aliened, released and confirmed, and by these
presents do grant, sell alien, release and confirm unto the said Lewis
Morrell his heirs and assigns forever one certain tract or parcel
of land lying and being in the County aforesaid containing
thirteen and one half acres and bounded as followeth, to wit,
beginning at a lightwood post a corner of Titus Edwards
near his house in Lewis Morrells line, thence along s^d Edwards
line to the run of the little Swamp in Lewis Morrells line, thence
down the run of said Swamp to the fork a corner of the corner
of Mary Edwards, thence up the front of said Swamp & along the
corner line to a black gum another corner of the corner in Lewis
Morrells line, thence along the said Morrells line to the beginning
with all woods, trees, meadows, waters, waters courses, ~~rights~~
commodities and appurtenances whatsoever, belonging to the said tract
belonging or in any way appurtenant to the same and by holding the same tract or parcel of land
or parcel of land and premises to the only proper use & behoof of
the said Lewis Morrell his heirs and assigns forever and the said Nathan
Edwards and Seditah his wife for themselves, their heirs executors
and assigns do hereby grant, sell, alien, release and confirm unto the said Lewis Morrell his heirs
and assigns that they should and may at all times forever
hereafter peaceably hold and occupy possess all and singular
the said thirteen and one half acres of land and premises as above
mentioned with the appurtenances thereto belonging unto the said Lewis
Morrell the said Nathan Edwards & Seditah his wife for themselves, their
heirs executors, assigns do doth forever warrant & defend the title of the
same and every part thereof against all and singular persons or persons
whatsoever. In witness whereof the said Nathan Edwards & Seditah his wife
