

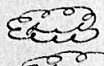
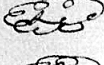

This Indenture

made this

21st day of July 1819 between Jason Rowe & Elizabeth his wife also Rebekah Rowe widow and relict of Samuel Rowe dec'd in right of her dower in those lands during her natural life all of the County of Southampton State of Virginia and Parish of Attomah of the one part and Jesse Lankford of the same County State & Parish of the other part Witnesseth that the said Jason Rowe and Elizabeth his wife and Rebekah ^{Rowe} as aforesaid for any in consideration of the sum of fifty dollars current money of Virginia to them in hand paid by the said Jesse Lankford the receipt whereof the said Jason Rowe and Elizabeth his wife and Rebekah Rowe widow of Samuel Rowe dec'd doth acknowledge themselves fully and amply satisfied and paid, hath granted, bargained sold, aliened, conveyed and confirmed and by these presents doth grant bargain and sell, alien, convey and confirm unto the said Jesse Lankford his heirs and assigns forever an certain tract or parcel of land and premises situate lying and being in the County State and Parish aforesaid, containing by estimation three 1/2's acres be the same more or less and bounded as follows to wit beginning at a red oak standing at the west end of the old dam or Jesse Lankfords line thence along said old dam to a small pine standing near the fence a corner of Jason Rowe thence a straight line up the side of the old pond to a small black gum standing on the side of the said Pond thence a straight line to a small gum thence a straight line to a black gum still standing up the side of the pond thence a straight line to a small ash or cutting standing in the south branch of the said pond thence rather a west course a straight line to a gum standing in the western branch of the pond a corner tree in Jesse Lankfords line thence down said branch and old pond along said Lankfords line to the said red oak a corner tree to the first station also together with all houses out houses edifices buildings yards gardens orchards ways waters and water courses whatsoever belonging or in anywise appertaining to the said tract or parcel of land and premises to have and to hold the same unto the said Jesse Lankford to him and to his heirs forever and the said Jason Rowe and Elizabeth his wife and Rebekah Rowe widow of the aforesaid Samuel Rowe dec'd for themselves their heirs executors and assigns doth by these presents covenant and grant to and with the said Jesse Lankford his heirs and assigns that they will by these presents warrant and forever defend all right title claim or demand of any person or persons claiming or demanding the same or any part or parcel thereof in court or without the said Jason Rowe & Elizabeth his wife and Rebekah Rowe widow of Samuel Rowe dec'd hath hereunto set their hands & affixed their seals this day and year within written signed sealed and declared in the presence of
