In consideration of the sum of sixteen hundred and seventy one dollars
and 93 cents Current money of Virginia in hand paid to the said
Trustees by the said Thomas Ridley or secured to be paid by the
said Thomas Ridley to the said Trustees and their Successors their
grants bargained and sold and by these presents do Grant bargain
and sell unto the said Thomas Ridley his heirs and assigns the afore-
said tract of land containing Four hundred and eighty one acres
being a part of the said tract mentioned in the aforesaid act of
assembly and bounded as follows to wit beginning at a red oak
corner of Lots No 1 & 2 in Ridge line thence N 16° E 102 pole to a
pine corner in said Ridge line thence E 371 pole to a small red oak
corner in the new line of marked trees thence S 6° E 162 pole along
the said new line of marked trees to a red oak corner of lots no 2 & 3 thence E 160
pole to the beginning known and designated in the plat of said Land
by lot No 3 together with all the profits advantages hereditaments and
appurtenances whatsoever to the said tract or parcel of Land in anywise
appertaining or belonging To have and to hold the said tract lot or par-
cel of Land with the appurtenances thereto belonging to him the said Tho-
mas Ridley his heirs and assigns to the only proper use and behoof
of the said Thomas Ridley his heirs and assigns forever and the said Indians
themselves (and their posterity) And the said Trustees do hereby com-
mand and agree to and with the said Thomas Ridley his heirs and assign-
s that they the said Indians and Trustees as aforesaid the said tract or
parcel of land with its appurtenances unto him the said Thomas Ridley
his heirs and assigns against them the said Indians and Trustees and
against all person whomsoever claiming by through or under them
as any of them shall and may by there fore ever power warrant and
defend the witnesses whereof the parties to the first and second parts
have hereunto set their hands and affixed their seals the day and year above
