This Indenture made this twentieth day of March in the year of our Lord One thousand eight hundred and twenty one between Henry Potter of the first part Miller Squire of the second part and John Barnes Polling H. Barnes and Augustine Pope of the third part Whereas the said Miller Squire on the first day of March one thousand eight hundred and twenty in order to secure the payment of the sum of twenty new dollars due Davis Bryant & Davis and John Seargeant a Bond and Christopher Sweeney to the amount of thirty dollars for a sum due said Pope to the amount of twenty dollars due a Bond due the said Polling H. Barnes for twenty dollars a bond due Henry Miller for the sum of one hundred and fifty dollars and a Bond due John Barnett for the sum of thirty dollars to the said John Barnes Polling H. Barnes and Augustine Pope and by indenture of Writ of that date came to the said Henry Potter his heirs Exrs. &c. the following property to wit One gray Horse one cart and load a parcel of land lying and being in the County of South Carolina a being part of the land which said Squire formerly held and containing one hundred and forty acres more or less and bounded by the mile square line of Bond Pope John Barnes Polling H. Barnes and Augustine Pope also a lot of stock of cattle sheep and swine belonging to said Miller Squire with all his house hold and kitchen furniture plantations and all every species of property belonging to said Miller Squire upon land for the use and purposes for such individuals mentioned and others as have the meeting and delivery of the said deed of Writ the said Miller Squire hath fully paid and satisfied to the said John Barnes Polling H. Barnes and Augustine Pope the several sums of money thirty pounds which the said John Barnes Polling H. Barnes and Augustine Pope with truly acknowledge Now therefore his indenture witnesses that for the consideration of money as well as for the further consideration of our beloved hands and funds by the said Miller Squire to the said Henry Potter and before the meeting and delivery of this present the receipt whereof is truly acknowledged the said Henry Potter with the assent and approbation of the said John Barnes Polling H. Barnes and Augustine Pope acquiesces by their having granted to the premises and the said John Barnes Polling H. Barnes and Augustine Pope have granted bargained and sold released and confirmed and by their promises to grant bargain and sell release and confirm unto the said Miller Squire all that title right title interest claim or demand both at Law and equity whosoever the said Henry Potter John Barnes Polling H. Barnes and Augustine Pope have or hold in the lands and premises above described to him and to hold the said tract or parcel of land together with the appurtenant property and the increase thereof since the meeting and delivery of the said deed of Writ to the said Miller Squire his heirs Executors administrators and assigns forever to the only proper use and behoof of him the said Miller Squire his heirs Executors administrators assigns forever and the said Henry Potter and John Barnes Polling H. Barnes and Augustine Pope for themselves their heirs Executors and administrators their heirs Executors and assigns forever unto the said Miller Squire his heirs Executors administrators the appurtenances as full and complete and entire as the same was or may
