This Indenture made this 1st day of September in the year one thousand
and eight hundred and twenty one between Elias Wick of the first part David
Wallace of the second part and John M. Gurley of the third part all of the
County of Southampton and State of Virginia. Witnesseth that whereas the
said Elias Wick stands justly indebted to the said David Wallace in his
individual capacity by note bearing date the 15th day of May 1820 Sum
of twenty two eight dollars and fifty nine cents also one other debt due to the said David
Wallace as surviving partner of Collins Hitchcock and Company by note bearing
date the 10th day of January one thousand eight hundred and 20 for the sum
of thirty nine dollars and fifty one cents and the said Elias Wick being willing
and desirous to secure the payment of the above or aforesaid debts of money
with six percent interest thereon to the said David Wallace with for and
in consideration of the debts aforesaid as well as for the further consideration of our deposes
to have the said Elias Wick in hand paid him by the said John M. Gurley the sum of money
the said Elias Wick doth hereby acknowledge his hath granted bargained and sold and
by these presents doth grant bargain sell unto the said John M. Gurley his heirs
executors administrators assigns former & future cattle 10 head called 2 further 20
one furniture 1 cart and mule 1 dozen sitting chairs 20 head of hogs 1 black
walnut table 1 safe 3 pots 3 pump tubs 1 Dutch oven 20 barrels corn to
have the said John M. Gurley his heirs executors administrators assigns forever bound
upon this express confidence and condition that in the said John M.
Gurley his heirs executors administrators assigns shall at any time at the request
of either of the said David Wallace or the said Elias Wick in case of
the failure to pay and satisfy the debts aforesaid sold to the highest bidder
for ready money after giving ten days previous notice of the time and
place of sale the same property herebefore conveyed to & much as will
be sufficient and out of the proceeds thereof first satisfy the debts aforesaid
with the interest accruing and all cost and expenses of carrying this
Indenture into effect and the surplus if any pay over to the said Elias
Wick his heirs executors administrators assigns of the said parties have
hereunto set their hands & seals the day and year above written
