 forever all their interest title claims or demand of in and to one certain
 tract or parcel of Land lying and being in the aforesaid county of
 Southampton and Parish of Saint Peters being a part of the said
 plantation Jordan Ticks their father and engid and supposed of containing
 by a late survey fifty two and three quarter acres be the same more
